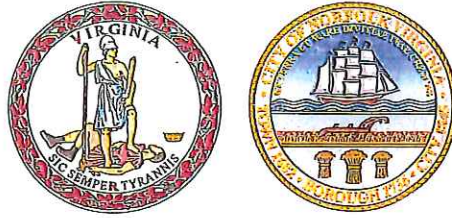

RE: Simple Possession of Marijuana Cases on Appeal

Dear Judge Jones and Mr. Schaefer:

As the Court and this Office definitively share an interest in the fair and efficient administration of justice, I write today with an update for the Court regarding this Office's handling of the cases of simple possession of marijuana on appeal.

Effective today's date (March 1, 2019) and pursuant to the discretion vested in me by Virginia Code § 15.2-1627(B), this Office will cease prosecuting cases appealed from Norfolk General District Court to Norfolk Circuit Court in which the sole charge on appeal is the violation of Possession of Marijuana, Virginia Code § 18.2-250.1. Simply, this Office is no longer picking up these cases. In addition, for such cases currently set for trial in Norfolk Circuit Court, I am directing this Office's prosecutors to withdraw from representing the Commonwealth, again pursuant to Virginia Code 15.2-1627(B), with the exception of cases on appeal pursuant to Virginia Code § 16.1-232 and cases CR18002659-00, CR18002608-00, and CR18002647-00.

For these three cases, each scheduled for trial on June 4, 2019, I respectfully inform you I will be filing a petition for a writ of mandamus from the Virginia Supreme Court. Please know I fully appreciate that the Court's denials of this Office's Motions to Nolle Prosequi/Dismiss in the cases were made on a good faith basis and my initiation of this litigation is in the same vein. Seeking a decision from the Virginia Supreme Court regarding this legal disagreement is in keeping with our collective pursuit of justice and the appropriate separation of powers.

I certainly understand my decision to withdraw this Office from the cases of simple possession of marijuana on appeal, as the Virginia Code allows, now results in operational changes for the remaining involved parties – the Court, the Clerk’s Office, law enforcement (largely the Norfolk Police Department), and defense counsel. I stand ready to assist everyone with the logistical steps necessary. Please do not hesitate to contact me or Chief Deputy Commonwealth’s Attorney Brent Johnson if this Office can be of assistance.
